Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 12, 2024, placed the rating(s) of Satish Agro Industries (SAI) under the 'issuer non-cooperating' category as SAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2025, November 07, 2025, November 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Indore (Madhya Pradesh) based Satish Agro Industries (SAI) was formed as a proprietorship concern by Mr. Satish Jain in 1998. SAI is engaged in manufacturing of agricultural spray pumps, power sprayers and other machinery parts. The firm supplies its product to government departments, private sector unit and direct counter sale to farmers.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SAI to 'Issuer Not Cooperating' category vide press release dated January 06, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
