### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 22, 2025, placed the rating(s) of Amul Feed Private Limited (AFPL) under the 'issuer non-cooperating' category as AFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 08, 2025, December 18, 2025, December 28, 2025, among others.

In line with the extant SEBI guidelines, CareEdge Ratings. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Amul Feed Private Limited. (AFPL) incorporated in September 1997 as Ahmad Vyapar Pvt Ltd, (AVPL) to setup a trading business near Patna and remained dormant thereafter. During December 2003, present promoters took over the business of AVPL and rechristened as AFPL and initiated a hatchery business. In recent past, the company has completed a poultry feed production unit at Ranipur Chak- Patna. The unit has started operation from January 2015. The day-to-day affairs of the company are looked after by Mr. Ashok Kumar Singh (Director) with adequate support from other three directors and a team of experienced personnel.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of AFPL into ISSUER NOT COOPERATING category vide press release dated June 25, 2025, on account of its inability to carry out a review in the absence of requisite information from the company.

Brickwork has continued the rating assigned to the bank facilities of AFPL into ISSUER NOT COOPERATING category vide press release dated September 16, 2025, on account of its inability to carry out a review in the absence of requisite information from the company.
