Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release January 20, 2025, placed the rating(s) of Banglore Polycotters Private Limited (BPPL) under the 'issuer non-cooperating' category as BPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 06, 2025, December 16, 2025, December 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company and industry

Jaipur (Rajasthan) based Banglore Polycotters Private Limited (BPPL) was incorporated in 2007 by Mr. Deen Dayal Agarwal and Mrs. Shanti Lal Agarwal along with their family members. BPPL is engaged in the business of manufacturing of High Density Polyethylene (HDPE) laminated fabrics and woven sack bags from HDPE fabrics. The plant of the company is located at Jaipur. The company is also engaged in the trading of HDPE fabrics, powder and other packaging products.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BPPL into Issuer Not Cooperating category vide press release dated July 17, 2025 on account of its inability to carry out a review in the absence of requisite information.
