### Rationale & Key Rating Drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated December 04, 2024, placed the rating(s) of Kameshwar Industries (KI) under the 'issuer non-cooperating' category as KI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 20, 2025, October 30, 2025, November 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the company

Kadi based (Gujarat) KI was established in June, 2013 as a partnership firm to carry on the business of cotton ginning and pressing. It is currently managed by 6 partners and operates from its sole manufacturing plant situated in Kadi, Gujarat with an annual installed capacity of 66,00,000 Kg. of cotton bales and 1,25,00,000 Kg. of cotton seeds as on March 31, 2017. Partners purchase raw material in bulk quantity from farmers locally.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of KI into 'Issuer not-cooperating' category vide press release dated October 24, 2025 on account of non-availability of requisite information from the Firm.
