CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 05, 2025, placed the rating(s) of Him Steel Private Limited (HSPL) under the 'issuer non-cooperating' category as HSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2025, January 01, 2026, January 11, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Him Steel Pvt. Ltd. (HSPL) was incorporated by Mr. Ashok Raja and his brother Mr. S.S. Raja on May 03, 2011 for the purpose of trading in gold, silver and precious stones etc with the name M/s. Shree Bullion Pvt Ltd. Thereafter in FY15, the management decided to carry on the steel business and taken over an automatic steel plant situated at Bilaspur, Himachal Pradesh, with installed capacity of 1,26,667 Metric Tonnes Per Annum (MTPA).
