Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 03, 2024, placed the rating(s) of Satya Srinivasa Enterprises (SSE) under the 'issuer non-cooperating' category as SSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 19, 2025, October 29, 2025, November 08, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Andhra Pradesh based, Satya Srinivasa Enterprises (SSE) was established on October 16, 1992 as a partnership firm and promoted by Mr. Bhuma Srinivas, Mrs. Bhuma Adilakshmi and Mr. Bhuma Rama Rao. The firm is engaged in processing of cotton lint and cotton seeds. The manufacturing unit is spread in total area 0.66 acres located at Guntur, Andhra Pradesh. SSE purchases raw cotton (cotton kappas) from farmers and dealers located in and around Guntur, Andhra Pradesh. The firm processes the raw cotton and separates the lint and cotton seeds from raw cotton. Later on, pressing and compressing 3 CARE Ratings Limited Press Release cotton lint into bales. SSE also involves in trading of cotton lint. SSE sells bales to the customers in Andhra Pradesh and cotton seeds to oil mills located in Andhra Pradesh only.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SSE to the 'issuer not-cooperating' category vide press release dated July 30, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.

Brickwork has continued the ratings assigned to the bank facilities of SSE to the 'issuer not-cooperating' category vide press release dated September 11, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
