Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 26, 2024, placed the rating(s) of Plasto Eltronics Private Limited (PEPL) under the 'issuer non-cooperating' category as PEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 11, 2025, November 21, 2025, December 01, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Incorporated in December 2002, PEPL was promoted by Mr. Sabya Sachin Ghuwalewala, Mrs. Anita S Ghuwalewala, Mr. Swarochis S Ghuwalewala and Mrs. Shruti S Ghuwalewala. The company has been engaged in manufacturing of injection molded, fabricated, and extruded components such as meter covers, switchboards and batten-holder boards, etc.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PEPL Into Issuer Not Cooperating category vide press release dated November 10, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
