### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 31, 2024, placed the rating(s) of Shree Hari Steel Industries (SHSI) under the 'issuer non-cooperating' category as SHSI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHSI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 16, 2025, November 26, 2025, December 06, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Rourkela (Odisha) based Shree Hari Steel Industries (SHSI) was established in April 1991 as a proprietorship entity by Mr. Shiv Kumar Agarwal. Since its inception, SHSI has been engaged in trading of coal and iron & steel products.
