### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated December 18, 2024, placed the rating(s) of Raghu Rama Renewable Energy Limited (RRREL) under the 'issuer non-cooperating' category as RRREL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RRREL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 03, 2025, November 13, 2025, November 23, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Raghu Rama Renewable Energy Limited (RRREL) was incorporated in 2001 and is a subsidiary of Ind-Barath Power Infra Limited (IBPIL) of the Ind-Barath Group. The company operates 18-MW Biomass-based power plant in Ramnad district of Tamil Nadu with the plant commencing operation from October 2004. The primary source of fuel is biomass such as Prosopis Juliflora shrubs combined with wood powder and matchbox waste.
