### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated December 17, 2024, placed the rating(s) of Kaizen Cold Formed Steel Private Limited (KCFSP) under the 'issuer non-cooperating' category as KCFSP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KCFSP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 02, 2025, November 12, 2025, November 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings 's opinion is not sufficient to arrive at a fair rating.

KCFSP deals in trading of wide range of products steels such as HR coils/Sheets and CR Coils / Sheets other steels TMT Bars, channels etc.
