### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 21, 2025, placed the rating(s) of Shri Radhe Foods Product (SRFP) under the 'issuer non-cooperating' category as SRFP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRFP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 07, 2025, December 17, 2025, December 27, 2025, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Shri Radhe Foods Product (SRFP) is a proprietorship firm established by Mr. Gopal Agrawal in 2015. The firm is engaged in milling and processing of non-basmati rice. SRFP is operating from its sole manufacturing plant located at Gondia (Maharashtra). Further the firm is also engaged in sorting of rice at its plant.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SRFP under Issuer Not Cooperating category vide press release dated December 05, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
