Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 20, 2025, placed the rating(s) of Garg Granites Private Limited (GGPL) under the 'issuer non-cooperating' category as GGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 06, 2025, December 16, 2025, December 26, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Kishangarh (Rajasthan) based GGPL was incorporated in 1993 by Mr Sanjay Garg along with his family members. GGPL is engaged in the business of processing of marble blocks as well as trading of finished marble slabs and tiles. The processing plant of the company is located at Kishangarh.
