### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 02, 2024, placed the rating(s) of Kankai Pipes & Fittings Private Limited (KPFPL) under the 'issuer non-cooperating' category as KPFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KPFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 18, 2025, October 28, 2025, November 07, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

KPFPL is engaged in the manufacturing of plastic pipes & fittings (mainly cPVC pipes & fittings). The products manufactured by KPFPL are used in residential, commercial as well as industrial units.
