Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 10, 2025, placed the rating(s) of Karan Automobiles (A Unit of Bikaner Distributors Private Limited) (KAAUOBDPL) under the 'issuer non-cooperating' category as KAAUOBDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KAAUOBDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 26, 2025, December 06, 2025, December 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
