### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 12, 2024, placed the rating(s) of Bhandari Agrofeeds Private Limited (BAPL) under the 'issuer non-cooperating' category as BAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2025, November 07, 2025, November 17, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Bhandari Agrofeeds Private Limited (BAPL) was incorporated on February 21, 2014 to set up a unit for manufacturing on animal and cattle feeds at Uluberia, Howrah. The unit has started commercial operations from October 2016. The day-to-day affairs of the company are looked after by Mr Rajesh Bhandari (Managing Director) along with the help of other directors and a team of experienced personnel.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of BAPL into Issuer Not Cooperating category vide press release dated November 18, 2025 on account of its inability to carry out a review in the absence of requisite information.
