### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 05, 2024, placed the rating(s) of Om Sharda Logistics Solutions Private Limited (OSLSPL) under the 'issuer non-cooperating' category as OSLSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSLSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 21, 2025, October 31, 2025, November 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of OSLSPL have been revised on account of non-availability of requisite information.
