Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 04, 2024, placed the rating(s) of Sri Priya Agro Farms (SPAF) under the 'issuer non-cooperating' category as SPAF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPAF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 20, 2025, October 30, 2025, November 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Sri Priya Agro Farms (SPAF) was established in the year 2006 and promoted by Mr. Bommareddy Gokul Kumar Reddy (Managing Partner) and Mrs. Bommareddy Aruna Kumari (Partner). The firm is engaged in farming of egg, laying poultry birds (chickens) and trading of eggs, cull birds and their Manure. The firm sells its products like eggs and cull birds in West Bengal, Bhopal, Assam, Orissa to retailers through own sales personnel and through some dealers. The firm mainly buys chicks (small chickens) and raw materials for feeding of birds like rice broken, maize, sunflower oilcake, shell grit, minerals and soya from local traders.
