Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 09, 2025, placed the rating(s) of Kissan Solvex Private Limited (KSPL) under the 'issuer non-cooperating' category as KSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2025, December 05, 2025, December 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kissan Solvex Private Limited (KSPL) was incorporated as a private limited company in February 1988 and is currently being managed by Mr. Inderjit Singh and Mr. Kirandeep Singh. The company is engaged in the extraction of rice bran oil at its processing facility located in Jalalabad, Punjab. The company manufactures rice bran oil in semi-edible form for industrial use. The company is also engaged in the trading of rice bran.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KSPL into Issuer Not Cooperating category vide press release dated July 18, 2025 on account of its inability to carry out a review in the absence of requisite information.
