Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 12, 2024, placed the rating(s) of Ultra Alluminium Private Limited (UAPL) under the 'issuer non-cooperating' category as UAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2025, November 07, 2025, November 17, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Ultra Alluminium Private Limited (UAPL) was incorporated in September, 2009 and currently it is managed by Mr. Jaya Dayal Kedia and Mr. Prem Dayal Kedia. Since its incorporation the company has been engaged in the business of manufacturing of aluminium products like angles, channels, shafts, extrusions etc. The manufacturing plant of the company is located at Raipur, Chhattisgarh.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of UAPL into Issuer Not Cooperating category vide press release dated September 11, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
