Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 10, 2024, placed the rating(s) of Premier Spintex Private Limited (PSPL) under the 'issuer non-cooperating' category as PSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2025, November 05, 2025, November 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

PSPL is promoted by Mr. Haresh Trivedi and his wife Mrs. Parul Haresh Trivedi along with Mr. Hirabhai Ahir and Mrs. Jyotiben Ahir to enter into the cotton spinning business in June 2014. The company has changed its name to Premier Spintex Private Limited (PSPL) from January 21, 2022. PSPL is undertaking green-field project to set up a spinning mill to manufacture cotton carded yarn in Dholka (Ahmedabad) to manufacture 24's, 30's & 34's count cotton carded yarn with installed capacity of 13,056 spindles per annum.

Status of non-cooperation with previous CRA: ICRA has continued the ratings assigned to the bank facilities of PSPL to 'Issuer Not Cooperating' category vide press release dated January 29, 2026 on account of its inability to carry out a review in the absence of the requisite information from the company.
