Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 27, 2025, placed the rating(s) of Amrit Humifresh Preservation Private Limited (AHPPL) under the 'issuer non-cooperating' category as AHPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AHPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 23, 2025, January 02, 2026, February 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Amrit Humifresh Preservation Private Limited (AHPPL) was set-up in 2000 and became operational in 2003. AHPPL is currently being managed by Mr. Bal Krishan Gupta, Mrs. Geeta Aggarwal, Mr. Deepak Aggarwal, Mr. Manish Aggarwal and Miss Amita Aggarwal. The company is engaged in the business of providing space on rental basis in the cold storage for storage of fruits, vegetables, dry fruits and spices. Along with this the company also provides maintenance of storage facilities like refrigerators, cold rooms and freezers. The storage location of AHPPL is located in Sonipat, Haryana.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of AHPPL into 'Issuer not-cooperating' category vide press release dated January 13, 2026 on account of non-availability of requisite information from the company.
