Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 13, 2025, placed the rating(s) of Bajrang Nirman Private Limited (BNPL) under the 'issuer non-cooperating' category as BNPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BNPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 29, 2025, December 09, 2025, December 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Lucknow, Uttar Pradesh based Bajrang Nirman Private Limited (BNPL) was incorporated in January, 2006 as a private limited company by Ms. Anju Singh, Mr. Vipin Singh and Ms. Anu Gupta. BNPL is mainly engaged in road construction services. BNPL secures its major portion of tenders through open bidding from Government of Uttar Pradesh and Airport Authority of India.

Status of non-cooperation with previous CRA: India Rating has continued the rating assigned to the bank facilities of BNPL into Issuer Not Cooperating category vide press release dated June 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
