Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 04, 2025, placed the rating(s) of L. S. Rice Exports Private Limited (LSREPL) under the 'issuer non-cooperating' category as LSREPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LSREPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 21, 2025, December 31, 2025, January 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in 2008, L.S Rice Exports Private Limited (LSREPL) is engaged in the processing of paddy to produce basmati rice and non-basmati rice at its manufacturing facility located at Samna (Punjab). The company is also engaged in milling for various government entities.
