Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 06, 2024, placed the rating(s) of Pallavi Constructions (PC) under the 'issuer non-cooperating' category as PC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 22, 2025, November 01, 2025, November 11, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Telangana based, Pallavi Constructions (PC), was established in the year 1996 with its registered office at Punjagutta, Hyderabad. The promoters of the firm are Mr. P. Chandra Shekar Reddy (Managing Partner), Mr. K. Madhusudhan Reddy (Executive Partner) and remaining all are sleeping partners. They have experience of more than two decade in construction industry. The firm is primarily engaged in civil construction works majorly i.e., earth work excavation, lining, concreting, bridges and other construction works.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of PC to the 'issuer not-cooperating' category vide press release dated August 11, 2025 on account its inability to carryout review in the absence of requisite information from the firm.
