### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 10, 2024, placed the rating(s) of Shree Parashnath Re-Rolling Mills Limited (SPRML) under the 'issuer non-cooperating' category as SPRML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPRML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2025, November 05, 2025, November 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

SPRML, incorporated in 2002, was promoted by two brothers, Mr. Anil Kumar Jain and Mr. Vipin Kumar Jain, of Durgapur. The company is presently engaged in manufacturing of Billets, Wire Rods and Structural products like Angles, Channels, Joists, H Beam, MS Flat, MS Round and MS Scrap with manufacturing facility located at Durgapur in West Bengal. The products are sold under "PARAS" brand. In July 2014, SPRML was referred to CDR. In November 2014, CDR cell approved the restructuring package of the company with effective date of July 01, 2014.
