Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 31, 2024, placed the rating(s) of Sri Shankara Cancer Foundation (SSCF) under the 'issuer non-cooperating' category as SSCF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSCF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 16, 2025, November 26, 2025, December 06, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SSCF have been revised on account of non-availability of requisite information.

About the Trust

Sri Shankara Cancer Foundation (SSCF) is a public charitable trust, incorporated in April 2008 as a not-for-profit organization with a core purpose of providing cancer treatment to all, especially the poor. The trust runs a hospital by the name 'Sri Shankara Cancer Hospital and Research Center' in joint venture with Sri Sringeri Sharada Peetham Charitable Trust, Sringeri (Karnataka). The construction of the hospital was started in October 2010 and it started operations in August 2012. Currently, it has 360 beds under operation. The hospital provides healthcare services in radiotherapy, radiology, day care chemotherapy, nuclear medicine, and brachytherapy.
