### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 24, 2025, placed the rating(s) of Sri Balaji Industries (SBI) under the 'issuer non-cooperating' category as SBI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 10, 2025, December 20, 2025, December 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

SBI is a proprietorship concern, established in 2011 by Mr M R Subrahmanyam. The firm is engaged in distillation of Solvents used by petrochemical and other chemical manufacturing companies. In FY15, SBI had a surplus of Rs. 0.27 crore on a total operating income of Rs. 13.45 crore, as against PAT and TOI of Rs.0.27 crore and Rs.7.78 crore, respectively, in FY14.
