Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 09, 2024, placed the rating(s) of Shiromani Cold Storage Private Limited (SCSPL) under the 'issuer non-cooperating' category as SCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 25, 2025, November 04, 2025, November 14, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Rating's opinion is not sufficient to arrive at a fair rating.

Shiromani Cold Storage Private Limited (SCSPL), incorporated in the year 2010, is a Kolkata (West Bengal) based company, promoted by the Nandi family. It is engaged in the business of providing cold storage services to potato growing farmers and potato traders, having an installed storage capacity of 1,70,000 quintals in Bankura district of West Bengal. Besides providing cold storage facility, the company also works as a mediator between the farmers and marketers of potato by taking advances from marketers on behalf of the farmers in order to facilitate sale of potato stored and it also provides advances to farmers for farming of potato against potato stored. Apart from this it also provides additional services to farmers such as insurance of potatoes stored & drying of potatoes.
