### Rationale & Key Rating Drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated December 05, 2024, placed the rating(s) of Satyam Cottex (SC) under the 'issuer non-cooperating' category as SC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 21, 2025, October 31, 2025, November 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the firm

Satyam Cottex (SC) was setup as a partnership firm in April 2013 by Mr. Mehul R. Sanghani, Mr. Ashok K. Bhagiya, Mr. Mansukhbhai V. Sanghani and Shri Bhaveshbhal G.Chandrat, along with five other non-executive partners, based out of Rajkot, Gujarat. The firm is engaged in the business of cotton ginning and pressing to produce cotton bales and cotton seeds. The products are mainly used in the manufacturing of cotton yarn in the textile industry and oil extraction companies. The manufacturing unit of the firm is located at Tankara, Gujarat. The unit commenced commercial production from November 2013.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of SC into ISSUER NOT COOPERATING category vide press release dated October 22, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
