Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 22, 2025, placed the rating(s) of Contour Steel Engineering India Private Limited (CSEIPL) under the 'issuer non-cooperating' category as CSEIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CSEIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 08, 2025, December 18, 2025, December 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
