Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated December 30, 2024, placed the rating(s) of Preeti Buildcon Private Limited (PBPL) under the 'issuer non-cooperating' category as PBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 15, 2025, November 25, 2025 and December 05, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of PBPL have been revised on account of non – availability of requisite information.

Based in Delhi, PBPL is engaged in road construction and civil works for PWD, NHAI and other government agencies. The company has successfully completed various road construction projects majorly in the states of Uttar Pradesh and Uttarakhand.
