Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 24, 2025, placed the rating(s) of Gas Projects India Private Limited (GPIPL) under the 'issuer non-cooperating' category as GPIPL failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GPIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 10, 2025, December 20, 2025, December 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Gas Projects India Private Limited has its existence since 1982 as Sintech Equipment Mfg Co Private Limited later on during 2001 it got amalgamated into Gas Projects India Private Limited by Parikh Family. The company is engaged in manufacturing and installation of Auto LPG dispensing stations (ALDPs), Vessels, tankers and also supplies electrical, electronics, civil automation engineering goods. Further, GPIPL also generates revenue from turnkey solution services with manufacturing capability and PAN India service support network. GPIPL has its manufacturing facilities located at Navi Mumbai and registered office located at Ghatkopar Mumbai.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of GPIPL under Issuer Not Cooperating category vide press release dated October 30, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company
