### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 19, 2024, placed the rating(s) of Shroff Oil Manufacturing Company Private Limited (SOMCPL) under the 'issuer non-cooperating' category as SOMCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SOMCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2025, November 14, 2025, November 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in April, 1994 by Thakkar family, SOMCPL is engaged in the manufacturing of castor oil, castor deoiled cake and its derivatives which find application primarily in the manufacturing of soaps, lubricants, hydraulic and brake fluids, paints, dyes, coatings, inks, cold resistant plastics, wax and polish, nylon, pharmaceuticals and perfumes etc. SOMCPL's manufacturing unit is located at Luna in Baroda district of Gujarat. It had an installed capacity of 12,000 Metric Tonnes per Annum (MTPA) for castor oil and 14,500 MTPA for castor cake as on March 31, 2015.
