Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 10, 2024, placed the rating(s) of Nagayya Makkimane Shetty (NMS) under the 'issuer non-cooperating' category as NMS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NMS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2025, November 05, 2025, November 15, 2025 among others.

In line with the extant SEBI guidelines CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

NMS is engaged in civil construction works like construction and improvements of roads and drainage works relating to Public Works Department (PWD), Directorate of Municipal Administration (DMA), Karnataka Power Corporation Limited (KPCL), City Municipal Council (CMC), Panchayatiraj Engineering, Department (PRED), and Mangaluru City Corporation (MCC) etc. in the Karnataka state. The firm purchases materials like cement, steel, metal and Tar from local suppliers located in and around Karnataka. NMS procures work orders through online government tender websites.
