### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 06, 2024, placed the rating(s) of Rameshwar Cottex (RC) under the 'issuer non-cooperating' category as RC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 22, 2025, November 01, 2025, November 11, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

Rajkot (Gujarat) based RC is a partnership firm promoted by Mr. Pravin L Nakum, Mr. Kailash L Nakum and Mrs. Manjula K Nakum in August 2015. The Firm is engaged in cotton ginning and pressing to produce cotton bales and cotton seeds and also trading of raw cotton. Firm has also started Oil milling from April 2018. The manufacturing unit of the firm is located at Rajkot (Gujarat) and operates with an installed capacity of 54 Metric Tonnes per day as on March 31, 2018.

**Status of non-cooperation with previous CRA:** ICRA has continued the ratings assigned to the bank facilities of RC into 'Issuer not-cooperating' category vide press release dated May 01, 2025 on account of non-availability of requisite information from the Firm.
