Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 07, 2025, placed the rating(s) of KPT Spinning Mills Private Limited (KSMPL) under the 'issuer non-cooperating' category as KSMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 23, 2025, December 03, 2025, March 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

KPT Spinning Mills Private Limited (KSMPL) was incorporated in 2010 and began its commercial operation from August 2011. The company is promoted by Mr. K P Thangamuthu and Mr. Vetrivel who incur more than a decade of experience in textile sector. KSMPL is mainly engaged in the manufacturing of cotton yarn in Erode. The company manufactures cotton yarn with count range of 40s. The current installed capacity for manufacturing of the unit is 8400 spindles of cotton yarn per month.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KSMPL into Issuer Not Cooperating category vide press release dated July 14, 2025 on account of its inability to carry out a review in the absence of requisite information.
