### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 22, 2025, placed the rating(s) of Hema Dyeing And Printing Mills Private Limited (HDPMPL) under the 'issuer non-cooperating' category as HDPMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HDPMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 08, 2025, December 18, 2025, December 28, 2025, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Incorporated in 1995, Hema Dyeing & Printing Mills Private Limited (HDPMPL) is engaged in manufacturing and trading of blended finished fabrics. HDPMPL procures raw material (mainly yarn) from the domestic suppliers, and its entire revenue is generated from the domestic market. During FY15, HDPMPL shifted its manufacturing facility from Mahape, (Maharashtra) to Bhiwandi, (Maharashtra); and commercial production at new location commenced from August 2015.
