Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 09, 2025, placed the rating(s) of Proventus Ager India Private Limited (PAIPL) under the 'issuer non-cooperating' category as PAIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2025, December 05, 2025, December 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Vadodara-based PAIPL is promoted by Mr Doraprasad Nimmagada (promoter of Jay Polypack Private limited and Jay Agro Industries) in January 2015. The board of directors of PAPT comprises of Mr Doraprasad Nimmagada, his wife Mrs Aruna Nimmagada and his son Mr. Vijay Nimmagada. PAIPL has commenced the trading operations during FY16 (refers to the period April 1 to March 31) from May 2015. The company primarily procures Agrochemicals, Pesticides and Insecticides from its group entity i.e. Jay Agro Industries and markets it through dealers across the country.
