Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 20, 2025, placed the rating(s) of Super Infratech Private Limited (SIPL) under the 'issuer non-cooperating' category as SIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 06, 2025, December 16, 2025, December 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Super Infratech Private Limited (SIPL) was incorporated in March 2001 by Mr. Sujit Bordoloi and Mrs. Tribeni Bordoloi. Since its inception, the company has been engaged in civil construction activities for state and central government in the segment like construction of buildings, drains and roads. The company is classified as Class - 1 contractor by Public Works Division, Assam which indicates that the company can participate for higher value contracts release by government departments. SIPL participates in tenders and executes orders for the Public Works Department (Dibrugarh), Central Public Works Department (Guwahati), etc.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SIPL into ISSUER NOT COOPERATING category vide press release dated July 29, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
