### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 09, 2025, placed the rating(s) of P K And Company (PKC) under the 'issuer non-cooperating' category as PKC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PKC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2025, December 05, 2025, December 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

P K And Company (PKC) was established as a partnership firm on February 01, 1994 by Mr. Sajan Kumar Agarwala and Mr. Pawan Kumar Agarwala of Guwahati, Assam. Since its inception, the firm has been engaged in civil construction works for various state and central departments such as PWD (Roads), PWD (NH), Border Roads Organization, NF railways, CPWD, Flood Control, ONGC etc. BKC participates in tenders and executes orders. The firm has completed around 650 Kms of state road and national highways, around 130 numbers of bridges of well foundation, pile foundation, border fencing work, flood control protection work, around 45 Kms of alignment work of NF Railway.
