Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 20, 2024, placed the rating(s) of LSML Private Limited (LPL) under the 'issuer non-cooperating' category as LPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 05, 2025, November 15, 2025, November 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

LSML Private Limited is a joint venture between Shriram Group's SVL limited [Formerly known as Shriram Industrial Holding Ltd. (SIHL)] and Italy based Windfin BV, was incorporated to provide wind power solution on turnkey basis. LSML is engaged in the manufacturing, installation, commissioning of Wind Electric Generators (WEG), creating infrastructure such as site development and proving power evacuation facility for wind power projects, and their maintenance. The company has a fully integrated manufacturing facility in Chennai with a capacity of 144 WEG per annum and offers 1.5MW/1.8 MW WEG with different variants.

Status of non-cooperation with previous CRA: India Ratings has continued the ratings assigned to the bank facilities of LPL to the 'issuer not-cooperating' category vide press release dated July 18, 2025 on account of its inability to carryout review in the absence of requisite information from the company.
