Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 24, 2025, placed the rating(s) of Jampeswar Agro Udyog Private Limited (JAUPL) under the 'issuer non-cooperating' category as JAUPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JAUPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 10, 2025, December 20, 2025, December 30, 2025, among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

JAUPL was incorporated in Jan 28, 2012, by Mr Siddharth Mondal, Mr Rabindranath Chowdhury, Mr. Ramkrishna Banerjee and Mr. Somnath Banerjee of Birbhum, West Bengal with Mr. Siddharth Mondal being the main promoter. The company commenced operation since December 2013. JAUPL is engaged in the processing and milling of rice. The milling unit of the company is located at Birbhum, West Bengal.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of JAUPL into ISSUER NOT COOPERATING category vide press release dated October 23, 2025, on account of its inability to carry out a review in the absence of requisite information from the company.
