Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 29, 2025, placed the rating(s) of Restoration Engineers (RE) under the 'issuer non-cooperating' category as RE had failed to provide information for monitoring of the rating and as agreed to in its Rating Agreement. RE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 15, 2025, December 25, 2025, January 04, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Ahmedabad- (Gujarat) based Restoration Engineers (RE) was established in 2001 as a proprietorship firm by Mr. Jayesh Bhatia, which is engaged into road construction services. Subsequently in the year 2006, with entry of two new partners namely Mr. Naved Siddiqui and Ms. Shimul Mazmudar, the firm converted to a partnership firm. Ms. Shimul Mazmudar discontinued the partnership in the year of 2014. RE secures its major portion of tenders through open bidding with Government of Gujarat (GoG). The firm also gets work contract from private parties. The firm is registered as Class AA approved contractor (out of scale of Class AA to E) and 'Special Category I Road' class with Road and Building Department (R&B) of GoG.
