Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 28, 2025, placed the rating(s) of Mgm Infra Development Solutions Private Limited (MIDSPL) under the 'issuer non-cooperating' category as MIDSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MIDSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 14, 2026, January 24, 2026, February 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

MGM, incorporated in 2009, is a private limited company being managed by Mr Gurpreet Singh and Mr Manpreet Singh. The company is setting up a unit to manufacture concrete blocks, bricks, pavers etc at Roopnagar, Punjab. The commercial operations commenced from December, 2015 with substantial completion of project. The commercial operations were expected to commence from May, 2015, however, the same commenced from December, 2015 due to time overrun.
