Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of Ahuja Construction Engineers (ACE) under the 'issuer non-cooperating' category as ACE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Ahuja Construction Engineers (ACE) was established in 1986 as a proprietorship firm by Mr. Amarjeet Singh. ACE is engaged in the construction of industrial power houses such as Power Grid Corporation of India, ABB India Limited, Tata Power Firm Limited. The raw material consists mainly of cement, iron, steel bars etc. which it procures from various dealers and distributors in the domestic market.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of ACE into 'Issuer not-cooperating' category vide press release dated March 11, 2026 on account of non-availability of requisite information from the company.
