Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 08, 2025, placed the rating(s) of RajShri Constructions (RC) under the 'issuer non-cooperating' category as RC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 22, 2026, March 04, 2026, March 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Uttar Pradesh based, Rajshri Construction (RC) was established in July, 2009 as a partnership firm and is currently being managed by Mr. Sanjeev Goel, Mr. Deepak Goel, Ms. Mamta Goel and Ms. Monica Goel. The firm is engaged in construction of roads for government departments in the regions of Uttar Pradesh and Uttarakhand. The raw materials namely, gravel (rodi), tar coal etc., the firm procures from various domestic wholesalers based in Uttar Pradesh, Haryana and Uttarakhand.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RC into Issuer Not Cooperating category vide press release dated May 30, 2025 on account of its inability to carry out a review in the absence of requisite information.
