Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 24, 2025, placed the rating(s) of Hemodiaz Life Sciences Private Limited (HLSPL) under the 'issuer non-cooperating' category as HLSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HLSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 10, 2026, January 20, 2026, January 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Established in 1998, Hemodiaz Life Sciences Private Limited (HLSPL) is a private limited company and was initially incorporated under the name of Shri Behrai Lal Polymers Private Limited. In May 2012, its name was changed to HLSPL. The company is currently being managed by Mrs Rajni Dhawan and Mr Ashish Dhawan. New Delhi-based HLSPL is engaged in trading of PVC granules and medical equipment such as syringe, X-ray machines, ECG machines etc. Also, the company imports the PVC granules from Dubai, Taiwan while medical equipment is imported from China and Germany. The company sells the medical equipment's to hospitals all over India through distributor network. PVC granules are sold to plastic products manufacturers located in Delhi-NCR.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of HLSPL under Issuer Not Cooperating category vide press release dated October 07, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
