### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of Kolkata Marine Products Private Limited (KMPPL) under the 'issuer non-cooperating' category as KMPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KMPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Kolkata Marine Products Private Ltd (KMPPL) was incorporated on October 08, 2007 by Md. Safiullah and Md. Anwar Ali of Kolkata, West Bengal. The company is engaged in processing and export of sea food, primarily Dry Fish, Fish Maws, Fish Scale & Fish Skin. KMPPL has its own processing facilities at Digha Mohana, West Bengal and its freezing facilities on lease rental basis at Raja bazar, Kolkata, West Bengal (owned by Hindustan Ice & Cold Storage Co. Ltd.). The processing facility has an aggregate installed capacity of 1,200 Metric Tonnes Per Annum (MTPA) for processing of fish. KMPPL procures fish from the open market from farmers and agents for processing and export. The plant is appropriately located in proximity to several aquaculture farms in West Bengal which reduces the risk of raw material availability and also keeps the inward freight costs under control.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of KMPPL into ISSUER NOT COOPERATING category vide press release dated May 29, 2025, on account of its inability to carry out a review in the absence of requisite information from the company.

CRISIL has continued the rating assigned to the bank facilities of KMPPL into ISSUER NOT COOPERATING category vide press release dated November 13, 2025, on account of its inability to carry out a review in the absence of requisite information from the company.
