### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 10, 2025, placed the rating(s) of Calypso Agro Industries Private Limited (CAIPL) under the 'issuer non-cooperating' category as CAIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CAIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 24, 2026, March 06, 2026, March 16, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
