Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 05, 2025, placed the rating(s) of Alaknanda Fuel Private Limited (AFPL) under the 'issuer non-cooperating' category as AFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2025, January 01, 2026, January 11, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of AFPL have been revised on account of non-availability of requisite information.

About the company

Incorporated in March 2014, Alaknanda Fuel Private Limited (AFPL) is promoted by Mr. Anand Kumar Saraogi, Mr. Mukesh Kumar Bharuka, Mr. Vishal Sarada and Mr. Anurag Singhania. The company is into manufacturing of Polypropylene woven bags in the state of West Bengal with an aggregate installed capacity of 4320 metric tons per annum (MTPA). The company belongs to Alaknanda Group, which is engaged in manufacturing of iron and steel products namely TMT bars and mild steel rounds and sales under its own brands through flagship entity Alaknanda Sponge Iron Ltd. For diversification of its business profile, the group has set up a manufacturing plant for polypropylene woven bags under AFPL which has started its commercial operation from November 2018. AFPL is currently selling its product under the brand name of "Gemini".
